Notice is hereby given that a General Body Meeting (GBM) of the Supreme Court Advocates-on-Record Association (SCAORA) will be held on Wednesday, 12th August 2026 at 4:00 PM at the Indian Society of International Law (ISIL), Bhagwan Das Road, New Delhi, to transact the following agenda items:

1. To consider and pass a Resolution requesting that matters in the Supreme Court cause list be taken up strictly according to their serial numbers and to discontinue the existing sequence system followed by the Courts.
2. To consider and pass a Resolution for following improvement in Defect marking system:
 - a. Defects shall be scrutinised and notified within 48 hours of filing.
 - b. One-time defect scrutiny: Defects to be marked comprehensively at the first scrutiny itself. No fresh defects should be raised on subsequent scrutiny. In case of re-filing, any subsequent defect should be confined only to the re-filed/rectified material and not extend to scrutiny of the entire SLP afresh.
3. To consider and pass a Resolution to amend the Trust Deed of the Supreme Court Advocates-on-Record Welfare Trust so as to include all twelve elected Executive Committee Members as ex officio Trustees with voting rights.

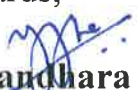
